Steve has also worked on many land use, zoning and (re)development, annexation projects as well as government relations and real estate litigation. He has counseled and litigated on behalf of real estate and business owners, real estate developers, investors, lenders, commercial landlords and tenants and many government agencies.

Steve's experience in eminent domain and condemnation includes large-scale federal, state and local public works projects, including new highways, highway extensions, expansions and reconfigurations, roadway and intersection expansions, electrical power stations, interstate pipelines, airports, municipal downtown redevelopments and municipal acquisitions in Cook, Will, DuPage, Lake, McHenry, Kankakee, Kendall, Kane and LaSalle Counties. Additionally, Steve has served as Special Assistant Attorney General representing both the Illinois Department of Transportation and the Illinois State Toll Highway Authority on large-scale infrastructure projects and land acquisition, including the I-355 South Extension, I-290/Eisenhower Expressway expansion and Roosevelt Road widening. Steve has also represented municipalities and other condemning authorities in eminent domain matters.
